Election laws are NOT being followed.

# 338,000+

more votes cast than voters who voted.

▶ The law says that the numbers of votes cast must equal the number of voters.

# 740,000+

ineligible voters cast votes.

▶ The law says only legally registered voters can cast votes.

# 2.4 million

NYSVoter ID numbers attached to

registrants.

▶ The law says that each voter in New York State receives ONE Voter ID number, for their voting life.

OUR FINDINGS SHOW THAT:

▶ Election officials certified provably inaccurate, non-compliant elections in 2020 and 2022.

▶ There is widescale manipulation of the New York State voter database (NYSVoter).

## WE CAN PROVE IT.

### And Cyber Professionals agree.

New York Citizens Audit findings that **NYSVoter has been breached** are now **PEER reviewed and published** in the *Journal of Information Warfare*, as seen in Volume 22, Issue 2, 2023, "The Caesar Cipher and Stacking the Deck in the New York State Voter Rolls" by Andrew Paquette. This shows that:

- ▶ Someone is manipulating our voter rolls, and carefully hiding that fact.
- ▶ It is a "Total Loss of Control" data breach according to law.
- ▶ Our critical national security infrastructure is severely impacted.
